Approval of Agenda and Minutes:

ADA Council updates

- Michael shared at the public hearing on the pedestrian Safety plan, he had an opportunity to have a conversation with Braxton Copley, the assistant city manager, discussing his oversight in Public Works relating to traffic signals. Assistant City Manager Copley intends to downgrade the traffic signals directly in front of the Bus Transfer Center at 9th and Quincy, as well as several other signals in town. After Michael shared his concerns regarding the changes, Assistant City Manager Copley was not interested in changing the plans. Michael plans to write a position paper on this issue, which will be shared with all 9 City Council members and members of the ADA.
