Approval of Agenda and Meeting Minutes: Commissioner Roberts motioned to approve the meeting agenda for August and the meeting minutes for July. Commissioner Kerls. The motion passed unanimously.

 - Chair Surritt and Commissioner Buzicky will follow up with staff via email for questions that can be asked to City legal staff for a response regarding options for the housing protection ordinance.

Old Business

 DEIAB, Affirmative Action, and HRC Updates – Zaynah shared that there are no updates from legal regarding immigration status protection at this time. The memo staff received from legal regarding DEIAB, Affirmative Action, and HRC changes

- has been provided to all HRC members who were present during the July meeting, and a follow-up email was shared with all members.
- O AARP Ongoing Discussion Zaynah shared that there are currently 395 survey responses, with about 90 responses from individuals who are not residents of Topeka.
 - Director Glaude' shared two more efforts the Office of Inclusive Communities will assist commissioners with to gather more data for the AARP survey. She shared that staff will reach out to the Jayhawk Area Agency on Aging to request a table for Medicare open enrollment, which will take place from October 15th to November 13th. Staff will get dates as soon as she speaks with the Executive Director and follows up with commissioners. The Office of Inclusive Communities will send a mailing to churches, asking them to share it with their congregations to increase participation.
